WHEREAS, the Papago Council did by Resolution No. 373-85 request that the Papago Tribe enter into a contract with the Secretary of the Interior pursuant to 23 U.S.C. Chapter 2, Section 204 (b), for the construction and/or improvement of a road on the Papago Reservation described in BIA Solicitation No. H54-R-5-6 to be paid for by funds allocated by the Secretary of Transportation from 1985 appropriations for Indian reservation roads; and

WHEREAS, Mr. Vernon Palmer and Mr. James Barber, representing Mr. James H. Stevens, Phoenix Area Director of the Bureau of Indian Affairs, did present to the Papago Council an alternative plan under which road construction on the Papago Reservation to be paid for with funds allocated in 1985 and road construction to be paid for with funds allocated in 1986 would be consolidated as Projects PIR 15 (18) and PIR 15 (19) under the direction of the bureau as outlined in the attached 1986 Papago Agency Road Construction Program and FY '86 Road Construction schedule upon the following firm conditions:

- 1. Advertising for bids for Project PIR 15 (18) will issue as soon as the bureau receives Advice of Allotment therefor.
- 2. The bid advertisements will provide that all contractors must comply with all applicable laws of the Papago Tribe, including the Transaction Privilege Taxes Ordinance and the Employment Rights Ordinance.
- The Bid advertisements will provide that all contractors and subcontractors will include the cost of sand and gravel in their respective bids; and
- WHEREAS, the Papago Council has received the foregoing plan and agrees that such a consolidated road construction project under the direction of the bureau pursuant to the foregoing conditions could be of benefit to the Papago Tribe.
- NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby withdraw its request contained in Resolution No. 373-85 that the

Papago Tribe contract the construction and/or improvemnet of the road described in BIA Solicitation No. H54-R-5-6 upon condition subsequent that the Phoenix Area Director forthwith confirm in writing to the Papago Tribe that the consolidated Projects PIR 15 (18) and PIR 15 (19) will be constructed under the three firm conditions outlined above, and that upon receipt of such written confirmation, the Chairman of the Papago Tribe shall confirm to the Area Director that the Papago Tribe has finally withdrawn the request contained in Resolution No. 373-85.

The foregoing Resolution was duly enacted by the Papago Council on the 6th day of November, 1985, at a meeting at which a quorum was present with a vote of 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the authority vested in the Papago Council by Section 2 (d) and (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
