## RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Establishing of the Apprenticeship Committee)

RES. NO. 838-85 1 WHEREAS, in recognizing the need for skilled craftsworkers in the construction 2 industry, the O'odham Tribal Council established apprenticeship 3 standards to be used in the local apprenticeship program for the 4 O'odham Nation; and 5WHEREAS, the standards require than an Apprenticeship Committee consisting of 6 five (5) members be appointed to administer and supervise said 7 standards in accordance with the duties prescribed; and 8 WHEREAS, the standards would be effectively implemented by an Apprenticeship 9 10 Committee consisting of representatives of tribal programs that are 11 actively involved in aspects of employment and training, to wit: 12 T.E.R.O. Employment Assistance J.T.P.A. T.W.E.P. 13 Skill Center 14 NOW, THEREFORE BE IT RESOLVED by the O'odham Tribal Council that it does hereby 15 establish and authorize an Apprenticeship Committee to consist of 16 representatives from the following programs or services: Employment 17 Assistance, J.T.P.A., Skill Center, T.E.R.O. and T.W.E.P.; and are 18 19 hereby authorized to perform the duties contained in the "Standards of 20 Apprenticeship and Training for the Papago Tribe". 21 The foregoing Resolution was duly enacted by the Papago Council on the 7th day 22 of November, 1985, at a meeting at which a quorum was present with a vote of 1640.0 for; -O- against; -O- not voting; and O1 absent, pursuant to the 23 authority vested in the Papago Council by Section 2 (e) (f) and (h)of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, 24 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 25 18, 1934 (48 Stat. 984).
