## RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Gu Achi District Budget Amendment FY 86)

RES. NO. 846-85

WHEREAS, the Gu Achi District Council did by resolution on October 17, 1985 approve the amendment of its FY 86 budget to hire a homemaker aide; and

WHEREAS, the total amount for the hiring of a homemaker aide is \$3,924.89 and the district council does have sufficient funds in its IIM account to cover the cost.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby approve the Gu Achi District amendment to its FY 86 budget of \$145,305.28 to reflect an increase of \$3,924.89 bringing the revised budget to \$149,230.17 and further authorizes expenditures in accordance therewith.

The foregoing Resolution was duly enacted by the Papago Council on the  $\underline{8th}$  day of November, 1985, at a meeting at which a quorum was present with a vote of  $\underline{1640.0}$  for;  $\underline{-0}$  against;  $\underline{-0}$  not voting; and  $\underline{-0}$  absent, pursuant to the authority vested in the Papago Council by Section 3 (a) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.
