

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Appointment of Presiding Judge, Donald Harvey)

RES. NO. 848-85

1 WHEREAS, Section 2A & B of Chapter 1 of the Law and Order Code of the Papago
2 Tribe, as amended by Ord. No. 05-83 provided that "The Papago Tribal
3 Courts shall consist of two regular Judges . . ."; and "who shall be
4 appointed by the Papago Council . . ." for a term of two (2) years; and

6 WHEREAS, The Tribal Council did interview three (3) applicants for the position
7 of Presiding Judge; and


8 WHEREAS, The Papago Council recommends that Donald Harvey be appointed to such
9 position.

10 WHEREAS, Donald Harvey does meet the qualifications for the position of
11 Presiding Judge of the Papago Tribal Courts; and

12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
13 appoint Donald Harvey as Presiding Judge of the Papago Tribal Courts
14 for a term of two (2) years from date of appointment.

16 The foregoing Resolution was duly enacted by the Papago Council on the 12th
17 day of November, 1985, at a meeting at which a quorum was present with a vote
18 of 806.0 for; 416.0 against; 418.0 not voting; and 03 absent, pursuant to the
19 authority vested in the Papago Council by Section 2 (e) of Article V of the
20 Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by
21 the Papago Tribe on December 12, 1936, and approved by the Secretary of the
Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934
(48 Stat. 984). Said Resolution is not subject to review by the Secretary of
the Interior and is effective as of the date of its enactment by the Papago
Council.
