## RESOLUTION OF THE PAPAGO TRIBAL COUNCIL (Authorizing District to carry over perviously allocated Revenue Sharing Funds to FY 86 Budget)

RESO NO. 866-85

WHEREAS, The Papago Council has in the past allocated Federal Revenue Sharing

Funds to the various districts which were not expended in the year in

which it was appropriated; and

WHEREAS, It is in the best interest of the Papago Tribe that each district be authorized to carry over any unexpended Revenue Sharing funds to its FY 86 Revenue Sharing budget.

NOW, THEREFORE BE IT RESOLVED by the Papago Council that it does hereby authorize each District, without further approval of the Council to carry over any unexpended Federal Revenue Sharing funds allocated to it in a previous year to its FY 86 Revenue Sharing budget and directs that all pertinent documents be processed through the Tribal Accounting Office.

The foregoing Resolution was duly enacted by the Papago Council on the 12th day of December, 1985, at a meeting at which a quorum was present with a vote of 1577.0 for; 63.0 against; -0- not voting; and -0- absent, pursuant to the authority vested in the Papago Council by Section 2(d) and (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
