WHEREAS, An application for enrollment as a member of the Papago Tribe of the
the Papago Reservation has been filed by or on behalf of:

CARMINE ZEPEDA 76-ND-82
("Applicant") (Namely Application No.)

filed on the 18TH day of JANAURY, 1982; and

WHEREAS, The Enrollment Committee has reviewed the application and has recom-
mended that the application be denied because the applicant failed
to establish the membership requirements of Section 1 of Article II
of the Constitution of the Papago Tribe, as amended; and

WHEREAS, The application has come on for hearing before this Council; and

WHEREAS, The Enrollment Committee did publish written notice of its recommen-
dation to reject the application and of this hearing, as required by
Section 2, Article IV of the Papago Enrollment Ordinance, amended
by Resolution No. 349-85, and neither the applicant or applicant's
sponsor appeared at this hearing; and

WHEREAS, The Papago Council has reviewed all of the evidence presented and
from such evidence finds that the applicant has failed to establish
the foregoing membership requirement(s).

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
determine that the application of:

CARMINE ZEPEDA

for enrollment as a member of the Papago Tribe is hereby rejected.


BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a

1 The foregoing Resolution was duly enacted by the Papago Council on the 12th
2 day of December, 1985, at a meeting at which a quorum was present with a vote
3 of 1640.0 for; -0- against; -0- not voting; and 03 absent; pursuant
4 to the authority vested in the Papago Council by Article II and Section 2 (f)
5 of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
6 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the
7 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
8 of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by
9 the Secretary of the Interior and is effective as of the date of its enactment
10 by the Papago Council.
