9	persons were members of the Papago Tribe on the date of the respective						
10	census rolls but that their names had been inadvertently omitted						
11	therefrom, and has recommended that their names be added to the rolls;

14	WHEREAS, the Papago Council has reviewed the recommendations of the Enrollment						
15	Committee and approves thereof.						
16	NOW, THEREFORE, BE IT RESOLVED by the Papago Council that, subject to the

30	approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not						
31	subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
