

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Adoption into Tribal Membership)

RES. NO. 909-85

1 WHEREAS, VELASCO, Chono; JOSE, Luisa; ZEPEDA, Carmine have made an application
2 for adoption into Tribal membership pursuant to Section 2 of Article
3 II of the Constitution of the Papago Tribe; and

5 WHEREAS, the Enrollment Committee has reviewed their respective applications,
6 had made a final determination that they are 1-1/2 degree or more of
7 Papago Indian blood, and have made a recommendation to the Papago
8 Council that their applications be approved, all in accordance with
9 the provisions with the Papago Enrollment Ordinance; and

10 WHEREAS, the Papago Council has reviewed the recommendation of the Enrollment
11 Committee and the evidence submitted in support of the individual
12 applications.

14 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the applications for
15 adoption filed by:




18 are hereby approved and they are hereby adopted into membership of the
19 Papago Tribe.

20 The foregoing Resolution was duly enacted by the Papago Council on the 12th
21 day of December, 1985, at a meeting at which a quorum was present with a vote
22 of 1640.0 for; -0- against; -0- not voting; and 04 absent, pursuant to the
23 authority vested in the Papago Council by Article II and Article V, Section 2
24 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
25 ratified by the Papago Tribe on December 12, 1936, and approved by the Secre-
26 tary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of
27 June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
28 Secretary of the Interior and is effective as of the date of its enactment by
29 the Papago Council.
