32 the Papago Tribe reduce this final determination in writing regarding





The foregoing Resolution was duly enacted by the Papago Council on the 12th day of December, 1985, at a meeting at which a quorum was present with a vote of 1352.5 for; -0- against; 159.0 not voting; and 128.0 absent, pursuant to the authority vested in the Papago Council by Article II and Article V, Section 2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
