(Tabling Pisinemo District Resolution No. 3-86)

1 WHEREAS, the Pisinemo District Representative did submit Resolution No. 3-86
2 from Pisinemo District regarding Tracy Maintenance Camp Lease; and

3 WHEREAS, the Tohono O'Odham Legislative Council needs more information on the
4 lease to determine if it is in the best interest of the Nation.

5 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does
6 hereby table Pisinemo District Resolution No. 3-86 (Tracy Maintenance
7 Camp Lease) until all necessary information is submitted.

9 The foregoing resolution was passed by the Tohono O'odham Council on the 5th
10 day of January, 1987, at a meeting at which a quorum was present with a vote of
11 1147.0 for; 110.5 against; 382.5 not voting; and 01 absent, pursuant to the
12 powers vested in the Council by Section 1 (a) of Article VI of the Constitu-
13 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
14 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
15 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
16 of June 18, 1934 (48 Stat. 984).
