6	land to be used for telephone equipment, storage space, warehouse,								
7	office site, and other authorized PTUA uses; and								
8	WHEREAS, land belonging to the Nation is available for these purposes, and it								
9	is in the best interest of the District and Nation to set aside land								
10 11	for PTUA use.								
12	NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that land in the Gu								
13	Achi District, (description attached) be set aside and allocated for								
14	PTUA use as described above.								
15	BE IT FURTHER RESOLVED that should PTUA not begin use of the above described								
16	land within twelve (12) months from this date, this resolution shall
