1 WHEREAS, the Tohono O'Odham Legislative Council did meet to consider Resolution
2 No. 1086-01 from the Gu Achi District Council; and


3 WHEREAS, the resolution does request the renewal of a lease agreement by the
4 ESCOM Radio System; and

5 WHEREAS, the Tohono O'Odham Legislative Council does request more documents to
6 assist the Legislature in making a decision on this matter.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does
9 hereby table Resolution No. 1086-01 from the Gu Achi District Council
10 and will reconsider this resolution when all documents are submitted.

11 The foregoing resolution was passed by the Tohono O'odham Council on the 5th
12 day of January, 1987, at a meeting at which a quorum was present with a vote of
13 1581.5 for; -0- against; 58.5 not voting; and 01 absent, pursuant to the powers
14 vested in the Council by Section 1 (a) of Article VI of the Constitution of
15 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
