

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of Budget & Finance Committee recommendations)

RES. NO. 103-87

1 WHEREAS, the Legislative Council received a report from the Budget & Finance  
2 Committee covering expenditures of all Tribal budgets and a review of  
3 our projected revenues received up to January 31, 1987; and

4 WHEREAS, the report from the Committee points out the problem of uncertainty  
5 for the Tribe's projected revenues; and

6 WHEREAS, the Budget & Finance Committee offers the following recommendations  
7 for adoption to help control expenditures of Tribal budgets, they are:  
8

- 9 1. based on projected revenues not guaranteed,  
10 Programs are to exist at the same level  
their budgets were approved at.
- 11 2. Programs showing overages are to come up  
12 with adjusted figures to show how they  
13 are to cover their overages at the next  
quarter reviews.
- 14 3. Programs are restricted from using their  
15 savings showing in the first quarter,  
16 unless justification shows an emergency  
17 need.
- 18 4. Programs are to stay within their monthly  
19 expenditure levels.

20 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby approves  
21 and adopts the above four (4) recommendations from the Budget &  
22 Finance Committee.

23 The foregoing resolution was passed by the Tohono O'odham Council on the 6th  
24 day of March, 1987, at a meeting at which a quorum was present with a vote of  
25 1545.0 for; 42.5 against; 52.5 not voting; and 02 absent, pursuant to the  
26 powers vested in the Council by Section 1 (b) of Article VI of the Constitu-  
27 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
28 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
29 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
30 of June 18, 1934 (48 Stat. 984).
