RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Authorizing P.L. 93-638 Contract with Bureau of Reclamation)

RES. NO. 105-87

WHEREAS, Public Law 97-293 of the Southern Arizona Water Rights Settlement Act provides for the Secretary to extend and improve the existing irrigation system on the San Xavier Reservation and design and construct within the Reservation such additional canals, laterals, farm ditches and irrigation works as necessary for the efficient distribution for agricultural purposes as necessary; and WHEREAS, P. L. 97-293 authorizes the use of P. L. 93-638 of the Indian Self Determination and Education Assistance Act for work required to im-9 plement the terms and conditions of the Southern Arizona Rights Act; 10 and

WHEREAS, the Tohono O'Odham Legislative Council has reviewed and approved a P. L. 93-638 contract proposal for the design of the existing farm irrigation system in the San Xavier District.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Nation does hereby apply and request that a P. L. 93-638 contract be executed for the design of 1.100 acres on the existing irrigation system of the San Xavier Reservation.

BE IT FURTHER RESOLVED that the term of this contract shall begin on April 01, 1987 and will terminate on March 31, 1988.

BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and or their designee be designated to negotiate and execute the contract and any amendments thereto.

The foregoing resolution was passed by the Tohono O'odham Council on the 6th day of March, 1987, at a meeting at which a quorum was present with a vote of 1145,0 for; 58.5 against; 436.5 not voting; and 02 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
