

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Rules of Hearing & Procedure)

RES. NO. 107-87

1 WHEREAS, the Tohono O'Odham Council is, by section 2 of article IX of the
2 Election Ordinance, charged with trying accusations for the removal of
3 elected officers and judges of the Tohono O'Odham Nation; and

4 WHEREAS, in order to assure that such trials are conducted in an efficient and
5 timely way and in order to protect the rights of the accused and
6 accuser, the council has determined that it is useful to adopt the
7 attached Rules of Hearing & Procedure Upon Accusations for Removal
8 with the changes recommended by the Rules Committee; and



10 WHEREAS, the Rules Committee has reviewed the proposed Rules of Hearing & Pro-
11 cedure Upon Accusations for Removal and recommended the following
12 changes:

- 13 1. Under 2.A., delete the following "the Chairman of..."
14 and place a period after "presented", also delete
15 "and his order shall govern unless overruled by the
16 Council"
- 17 2. Under 3, delete "unless otherwise directed by the
18 Chairman of the Council" and begin the statement
19 with "The trial..."
- 20 3. The numeration under #3 should be changed to alphabetical.

21 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that it does
22 hereby adopt the attached Rules of Hearing and Procedure Upon Accu-
23 sations for Removal with the above changes recommended by the Rules
24 Committee.

25 The foregoing resolution was passed by the Tohono O'odham Council on the 27th
26 day of March, 1987, at a meeting at which a quorum was present with a vote of
27 1044.5 for; 468.5 against; 127.0 not voting; and 03 absent, pursuant to the
28 powers vested in the Council by Section 1 (a) of Article VI of the Constitu-
29 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
30 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
31 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
32 of June 18, 1934 (48 Stat. 984).
