(Hickiwan District Revenue Sharing Budget-1987)


1 WHEREAS, the Tohono O'Odham Nation's Legislative Council allocated the said
2 amount of \$13,401.00 of Federal Revenue Sharing funds to the Hickiwan
3 District; and
4 WHEREAS, the Hickiwan District Council has heard evidence concerning the use of
5 such funds pursuant to the requests presented at the public hearing
6 including the attached resolution of the District Council of the
7 Hickiwan District; and
8 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the attached
9 budget and approves of the same.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
12 the \$13,401.00 of Federal Revenue Sharing funds allocated to the
13 Hickiwan District be distributed in accordance with the requests
14 presented at the public hearing and that it does hereby approve the
15 attached 1987 Revenue Sharing budget of Hickiwan District and
16 authorize expenditures in accordance therewith.

18 The foregoing resolution was passed by the Tohono O'odham Council on the 6th
19 day of January, 1987, at a meeting at which a quorum was present with a vote of
20 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the powers
21 vested in the Council by Section 1 (d) of Article VI of the Constitution of the
22 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).



5 either approve or disapprove it within 48 hours of submittal.


