

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Reaffirming Judiciary Committee's Rules of  
Hearing & Procedure)

RES. NO. 108-87

1 WHEREAS, the Judiciary Committee of the Tohono O'Odham Council is, by section 2  
2 of article IX of the Election Ordinance, charged with conducting  
3 hearings to determine whether reasonable cause exists for the council  
4 to try accusations for the removal of elected officers and judges of  
5 the Tohono O'Odham Nation; and  
6

7 WHEREAS, in order to assure that such hearings are conducted in an efficient  
8 and timely way and in order to protect the rights of the accused and  
9 accuser and the confidentiality of information submitted, the  
10 committee has determined that it is useful to adopt the attached Rules  
11 of Hearing & Procedure Upon Accusations for Removal; and

13 WHEREAS, the Legislative Council hereby reaffirms the Judiciary Committee's  
14 Rules of Hearing & Procedure, but to include the same amendments  
15 recommended and adopted for the Council's Rules of Hearing and Pro-  
16 cedure, they are:

- 17 1. Under 2.A., delete the following "the Chairman of..."  
18 and place a period after "presented", also delete  
19 "and his order shall govern unless overruled by the  
20 Council"
- 20 2. Under 3, delete "unless otherwise directed by the  
21 Chairman of the Council" and begin the statement  
22 with "The trial..."
- 22 3. The numeration under #3 should be changed to  
23 alphabetical.

24 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it does hereby  
25 adopt the attached Rules of Hearing and Procedure Upon Accusations for  
26 Removal and to include the above amendments.

28 The foregoing resolution was passed by the Tohono O'odham Council on the 27th  
29 day of March, 1987, at a meeting at which a quorum was present with a vote of  
30 864.5 for; 226.0 against; 549.5 not voting; and 02 absent, pursuant to the  
31 powers vested in the Council by Section 1 (a) of Article VI of the Constitu-  
32 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
of June 18, 1934 (48 Stat. 984).
