- Chairman of the Council" and begin the statement with "The trial..."
- The numeration under #3 should be changed to alphabetical.

NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it does hereby adopt the attached Rules of Hearing and Procedure Upon Accusations for Removal and to include the above amendments.
