

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
 (Override veto on Resolution No.'s 84-87, 86-87, 87-87,
 89-87 and 90-87)

RES. NO. 117-87

1 WHEREAS, the Tohono O'Odham Legislative Council did by Resolution No. 84-87
 2 revote on the top six candidates for PTUA, and by Resolution No. 86-87
 3 have a run-off between the two candidates for TERO Commission, and by
 4 Resolution No. 87-87 certify the appointment of the TERO Commission,
 5 by Resolution No. 89-87 certify the appointment of the Farm Board
 6 Members and by Resolution No. 90-87 certify the appointment of PTUA
 7 Board; and
 8

9 WHEREAS, upon presentation of Resolution No.'s 84-87, 86-87, 87-87, 89-87 and
 10 90-87 to the Chairman of the Tohono O'Odham Nation he did disapprove
 11 thereof and returning it to the Council with his objections in
 12 accordance with the provisions of Article VII, Section 5 of the
 13 Constitution of the Tohono O'Odham Nation; and

15 WHEREAS, the Council has reviewed the Chairman's objections and after consider-
 16 ation again voted to pass Resolution No.'s 84-87, 86-87, 87-87, 89-87
 17 and 90-87.

18 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does
 19 hereby override the Chairman's veto of Resolution No.'s 84-87, 86-87,
 20 87-87, 89-87 and 90-87 by a vote of two-thirds (2/3) of the votes
 21 cast.

23 The foregoing resolution was presented to the Tohono O'odham Council on the 6th
 24 day of April, 1987, at a meeting at which a quorum was present and by a vote of
 25 354.5 for; 1088.5 against; 197.0 not voting; and -0- absent, failed to over-
 26 ride the Chairman's veto of Resolution No.'s 84-87, 86-87, 87-87, 89-87 and
 27 90-87 pursuant to the powers vested in the Council by Section 5 of Article VII
 28 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham
 Nation on January 18, 1986, and approved by the Acting Deputy Assistant
 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
 16 of the Act of June 18, 1934 (48 Stat. 984).
