## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Override veto on Resolution No. 91-87)

RES. NO. 119-87

WHEREAS, the Tohono O'Odham Legislative Council did by Resolution No. 91-87 1 approved the Environmental Protection Agency-Safe Water Drinking Act 2 3 Proposal; and 4 WHEREAS, upon presentation of Resolution No. 91-87 to the Chairman of the 5 Tohono O'Odham Nation he did disapprove thereof and returning it to 6 the Council with his objections in accordance with the provisions of 7 Article VII, Section 5 of the Constitution of the Tohono O'Odham 8 Nation; and 9 WHEREAS, the Council has reviewed the Chairman's objections and after 10 consideration again voted to pass Resolution No. 91-87. 11 12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does 13 hereby override the Chairman's veto of Resolution No. 91-87, by a vote 14 of two-thirds (2/3) of the votes cast. 15 The foregoing resolution was presented to the Tohono O'odham Council on the 6th day of April, 1987, at a meeting at which a quorum was present and by a vote of 16 1192.0 for; 389.5 against; 58.5 not voting; and -0- absent, did override the 17 Chairman's veto of Resolution No. 91-87 pursuant to the powers vested in the Council by Section 5 of Article VII of the Constitution of the Tohono O'odham 18 Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 19 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 20 TOHONO O'ODHAM LEGISLATIVE COUNCIL 21 22 23 Harriet Toro, Legislative Chairperson \_ day of <u>April</u>, 1987. 24 25 ATTEST: 26 27 28 Acting Legislative Secretary 20th day of your 29
