## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Override veto of Resolution No. 99-87)

RES. NO. 120-87

WHEREAS, the Tohono O'Odham Legislative Council did by Resolution No. 99-87 1 2 adopt the Statement of Organization and By-laws of the Hia Ced O'Odham 3 Policy Board; and 4 WHEREAS, upon presentation of Resolution No. 99-87 to the Chairman of the 5 Tohono O'Odham Nation he did disapprove thereof and returning it to the 6 Council with his objections in accordance with the provisions of 7 Article VII, Section 5 of the Constitution of the Tohono O'Odham 8 Nation; and 9 WHEREAS, the Council has reviewed the Chairman's objections and after consider-10 ation again voted to pass Resolution No. 99-87. 11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does 13 hereby override the Chairman's veto of Resolution No. 99-87, by a vote 14 of two-thirds (2/3) of the votes cast. 15 16 The foregoing resolution was presented to the Tohono O'odham Council on the 6th day of April, 1987, at a meeting at which a quorum was present and by a vote of 17 1265.5 for; 63.0 against; 311.5 not voting; and -0- absent, did override the Chairman's veto of Resolution No. 99-87 pursuant to the powers vested in the 18 Council by Section 5 of Article VII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved 19 by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 20 21 TOHONO O'ODHAM LEGISLATIVE COUNCIL 22 23 Toro, Legislative Chairperson 24 25 26 ATTEST: 27 28 29 Acting Legislative Secretary DATA day of Corl 30 31 Said Resolution was submitted for approval to the office of the Chairman of the
