

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override veto of Resolution No. 99-87)

RES. NO. 120-87

1 WHEREAS, the Tohono O'Odham Legislative Council did by Resolution No. 99-87
2 adopt the Statement of Organization and By-laws of the Hia Ced O'Odham
3 Policy Board; and


4 WHEREAS, upon presentation of Resolution No. 99-87 to the Chairman of the
5 Tohono O'Odham Nation he did disapprove thereof and returning it to the
6 Council with his objections in accordance with the provisions of
7 Article VII, Section 5 of the Constitution of the Tohono O'Odham
8 Nation; and

10 WHEREAS, the Council has reviewed the Chairman's objections and after consider-
11 ation again voted to pass Resolution No. 99-87.


12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does
13 hereby override the Chairman's veto of Resolution No. 99-87, by a vote
14 of two-thirds (2/3) of the votes cast.

16 The foregoing resolution was presented to the Tohono O'odham Council on the 6th
17 day of April, 1987, at a meeting at which a quorum was present and by a vote of
18 1265.5 for; 63.0 against; 311.5 not voting; and -0- absent, did override the
19 Chairman's veto of Resolution No. 99-87 pursuant to the powers vested in the
20 Council by Section 5 of Article VII of the Constitution of the Tohono O'odham
21 Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved
22 by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March
23 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
