

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of Water Resources Contract Amendment)

RES. NO. 126-87

1 WHEREAS, Section 303 (b) (1) of Title II of P. L. 97-293, the Southern Arizona  
2 Water Rights Settlement Act of 1982 authorized and directed that a  
3 study be done to determine the availability and suitability of Water  
4 Resources within the Tohono O'Odham Nation; and

5 WHEREAS, the Tohono O'Odham Nation has entered into a multi-year contract with  
6 the Bureau of Indian Affairs; and

7 WHEREAS, any amendments affecting the funding or funding levels of the contract  
8 shall be submitted for review and approval by the Tohono O'Odham  
9 Legislative Council; and

10 WHEREAS, Congress has appropriated funds for the study of Water Resources  
11 within the Tohono O'Odham Nation; and


12 WHEREAS, an amendment has been submitted by the Tohono O'Odham Nation Water  
13 Resource Program for the second year funding for review and approval.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does  
15 hereby approve this amendment to the Water Resources Study Contract in  
16 the amount of \$1,100,000.

17 BE IT FURTHER RESOLVED that Josiah Moore, Chairman; Francisco Jose Jr., Vice-  
18 Chairman or Rosita Ruiz, Treasurer of the Tohono O'Odham Nation are  
19 hereby authorized to negotiate and execute this amendment.

23 The foregoing resolution was passed by the Tohono O'odham Council on the 7th  
24 day of April, 1987, at a meeting at which a quorum was present with a vote of  
25 1519.5 for; -0- against; 120.5 not voting; and -0- absent, pursuant to the  
26 powers vested in the Council by Section 1 (f) of Article VI of the Constitu-  
27 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
28 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
29 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
30 of June 18, 1934 (48 Stat. 984).
