19	programs from which contracts are requested herewith which have not								
20	been negotiated and executed by the Bureau of Indian Affairs prior to								
21	the start of the funding year.								
22	BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco Jose, Jr. Vice-								
23	Chairman or Rosita N. Ruiz, Treasurer of the Tohono O'odham Nation								
24	are hereby authorized to negotiate and execute these contracts and								
25	any amendments thereto for the duration of the contracts.

27	The foregoing resolution was passed by the Tohono O'odham Council on the 7th day of April, 1987, at a meeting at which a quorum was present with a vote of								
28	vested in the Council by Section 1 (f) of Article VI of the Constitution of the								
29	Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian								
30	Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
