

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Skill Center-P. L. 93-638 Contract)

RES. NO. 129-87

1 WHEREAS, the Tohono O'Odham Nation is presently operating the Skill Center
2 Program for training in construction trades; and

3 WHEREAS, 25 CFR Part 271.2 requires that all proposals to recontract under
4 P. L. 93-638 be submitted to the Tohono O'Odham Council for approval
5 at least 120 days prior to the contract termination; and

6 WHEREAS, the Tohono O'odham Council does desire to contract for provision of
7 these services during FY 88; and

8
9 WHEREAS, the Tohono O'odham Council has reviewed and approved the Tohono
10 O'odham Skill Center Program contract.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does
12 authorize and request the Bureau of Indian Affairs to contract with
13 the Tohono O'odham Nation under P.L. 93-638 regulations and procedures
14 for the provision of services titled: Tohono O'odham Skill Center.

15 BE IT FURTHER RESOLVED that the term of this contract shall commence on
16 September 01, 1987 and end August 31, 1988.

18 BE IT FURTHER RESOLVED that the Tohono O'odham Nation will not fund or operate
19 programs from which contracts are requested herewith which have not
20 been negotiated and executed by the Bureau of Indian Affairs prior to
21 the start of the funding year.

22 BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco Jose, Jr. Vice-
23 Chairman or Rosita N. Ruiz, Treasurer of the Tohono O'odham Nation
24 are hereby authorized to negotiate and execute these contracts and
25 any amendments thereto for the duration of the contracts.

27 The foregoing resolution was passed by the Tohono O'odham Council on the 7th
28 day of April, 1987, at a meeting at which a quorum was present with a vote of
29 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the powers
30 vested in the Council by Section 1 (f) of Article VI of the Constitution of the
31 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary - Indian
32 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984).




