WHEREAS, the San Lucy District submitted an interim budget for the period of 1 2 April 1, to June 10, 1987 in the amount of \$250,000.00 to continue the 3 ongoing community development and economic development projects; and 4 WHEREAS, the budget amount of \$250,000.00 would be in the form of a loan 5 guaranty by the Tohono O'Odham Nation through a lending institution; 6 and 7 WHEREAS, the loan guaranty payment would be made by proceeds under P. L. 8 99-503; and 9 WHEREAS, the Commerce Committee informed the Council that the issues 10 surrounding the projects under the proposed budget are still being 11 12 pursued and reviewed by the Committee, but have not been completed to 13 offer the Legislative Council any recommendations; and 14 WHEREAS, the materials received on the San Lucy project are quite lengthy to 15 comprehend today to make any decision. 16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that 17 the interim budget for the San Lucy District is tabled until Friday, 18 April 10, 1987. 19 20 The foregoing resolution was passed by the Tohono O'odham Council on the 7th 21 day of April, 1987, at a meeting at which a quorum was present with a vote of 1555.0 for; 85.0against; -0- not voting; and -0- absent, pursuant to the powers 22 vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 23 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 24 1934 (48 Stat. 984).
