WHEREAS, the San Lucy District submitted an interim budget for the period of
April 01, to June 10, 1987 in the amount of \$250,000.00 to continue
the ongoing community development and economic development projects;
and
WHEREAS, the budget amount of \$250,000.00 would be in the form of a loan
guaranty by the Tohono O'Odham Nation through a lending institution;
and

WHEREAS, the loan guaranty payment would be made by proceeds under P. L. 99-503 (Gila Bend Indian Reservation Land Replacement Act); and

WHEREAS, the Representative from the San Lucy District explained the urgency of adopting this budget due to taking care of payroll, industrial business contracts, natural gas hazards, youth recreation and housing rehabilitation as well as the elderly building.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby adopts the San Lucy interim budget of \$250,000.00 in the form of a loan guaranty to be paid from proceeds under P. L. 99-503 (Gila Bend Indian Reservation Land Replacement Act.

The foregoing resolution was <u>defeated</u> by the Tohono O'odham Council on the <u>10th</u> day of <u>April</u>, <u>1987</u>, at a meeting at which a quorum was present with a vote of <u>572.5</u> for; <u>812.0</u> against; <u>255.5</u> not voting; and <u>-0-</u> absent, pursuant to the powers vested in the Council by Section 1 (d)(2)(5) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
