


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of San Lucy District interim budget)

RES. NO. 134-87


1 WHEREAS, the San Lucy District submitted an interim budget for the period of
2 April 01, to June 10, 1987 in the amount of \$250,000.00 to continue
3 the ongoing community development and economic development projects;
4 and
5 WHEREAS, the budget amount of \$250,000.00 would be in the form of a loan
6 guaranty by the Tohono O'Odham Nation through a lending institution;
7 and
8 WHEREAS, the loan guaranty payment would be made by proceeds under P. L. 99-503
9 (Gila Bend Indian Reservation Land Replacement Act); and
10 WHEREAS, the Representative from the San Lucy District explained the urgency of
11 adopting this budget due to taking care of payroll, industrial
12 business contracts, natural gas hazards, youth recreation and housing
13 rehabilitation as well as the elderly building.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council
16 hereby adopts the San Lucy interim budget of \$250,000.00 in the form
17 of a loan guaranty to be paid from proceeds under P. L. 99-503 (Gila
18 Bend Indian Reservation Land Replacement Act.

20 The foregoing resolution was defeated by the Tohono O'odham Council on the 10th
21 day of April, 1987, at a meeting at which a quorum was present with a vote of
22 572.5 for; 812.0 against; 255.5 not voting; and -0- absent, pursuant to the
23 powers vested in the Council by Section 1 (d)(2)(5) of Article VI of the Con-
24 stitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
25 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
26 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
27 of June 18, 1934 (48 Stat. 984).


