

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriation for Land Gift)

RES. NO. 135-87


1 WHEREAS, the Tohono O'Odham Council did by Resolution No. 675-85 approve the
2 gift of approximately 320 acres of land adjoining the Luke Air Force
3 Range to the United States in trust for the Tohono O'Odham Nation, and
4 did authorize the expenditure of \$500.00 to pay the costs associated
5 with a title search and policy; and

6 WHEREAS, the title search establishes that the land is subject real property
7 tax liens for the years 1986 and 1987 in the sum of approximately
8 \$1,600.00 and the title policy will cost approximately \$400.


10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that it does
11 hereby appropriate the sum of \$2,000.00 to pay the costs associated
12 with the issuance of a title policy and the payment of real property
13 tax liens necessary for the United States to accept title to the land
14 in trust for the Nation.

16 The foregoing resolution was passed by the Tohono O'odham Council on the 10th
17 day of April, 1987, at a meeting at which a quorum was present with a vote of
18 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the powers
19 vested in the Council by Section 1 (d) of Article VI of the Constitution of the
20 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
