1	WHEREAS, Section 1 (a) of Article II of the Constitution of the Tohono O'odham								
2	Nation provides that the Tohono O'odham Council can make additions								
3	and changes to the official census rolls of the Sells and Gila Bend								
5	Reservations dated January 1, 1937, and of the San Xavier Reservation								
6	dated January 1, 1940, subject to the approval of the Secretary of								
7	the Interior; and								
8	WHEREAS, the Enrollment Committee has determined that the following named

10	respective census rolls but that their names had been inadvertently omitted therefrom, and had recommended that their names be added to the rolls; and

14	WHEREAS, the Tohono O'odham Council has reviewed the recommendations of the En-								
15	rollment Committee and approves thereof.								
16	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that, subject to								
17	the approval of the Secretary of the Interior, the names of the								
18	following persons be added to the official census rolls of the Sells,
