

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Commerce Committee Contract Proposal)

RES. NO. 13-87

1 WHEREAS, Rosemary Lopez, Chairperson of the Commerce Committee did receive a
2 contract proposed by Dan Press representing the firm of HERON,
3 BURCHETTE, RUCKERT & ROCKWELL; and

4 WHEREAS, the contract provides the mechanism for developing a comprehensive
5 approach to economic development; and

6 WHEREAS, Dan Press has in the past provided services to the Nation in the area
7 of T.E.R.O. and Health; and

8 WHEREAS, the Tohono O'Odham Legislative Council does see a need to utilize the
9 services proposed in this contract.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council
11 hereby approves the proposal to develop a comprehensive approach to
12 economic development.

13 BE IT FURTHER RESOLVED that upon request Mr. Press shall assist the Legislative
14 Committees in developing their charters.


15 BE IT FURTHER RESOLVED that any codes, by-laws or policies shall not be a
16 duplication prepared for other Indian Nations, Bands, Communities
17 or Tribes.

18 BE IT FURTHER RESOLVED that the Budget & Finance Committee shall seek
19 funding to pay costs for the services of Mr. Press.

20 BE IT FURTHER RESOLVED that the terms of the contract shall be renegotiated by
21 the Commerce Committee and final approval shall be made by the Tohono
22 O'Odham Legislative Council.

23 The foregoing resolution was passed by the Tohono O'odham Council on the 6th
24 day of January, 1987, at a meeting at which a quorum was present with a vote of
25 900.5 for; 543.0 against; 196.5 not voting; and 02 absent, pursuant to the
26 powers vested in the Council by Section 1 (f) of Article VI of the Constitu-
27 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
28 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
29 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
30 of June 18, 1934 (48 Stat. 984).
