1	WHEREAS, Rosemary Lopez, Chairperson of the Commerce Committee did receive a
2	contract proposed by Dan Press representing the firm of HERON,
3	BURCHETTE, RUCKERT & ROCKWELL; and
4	WHEREAS, the contract provides the mechanism for developing a comprehensive
5	approach to economic development; and
6	WHEREAS, Dan Press has in the past provided services to the Nation in the area
7	of T.E.R.O. and Health; and
8	WHEREAS, the Tohono O'Odham Legislative Council does see a need to utilize the
10	services proposed in this contract.
11	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council
12	hereby approves the proposal to develop a comprehensive approach to
13	economic development.
14	BE IT FURTHER RESOLVED that upon request Mr. Press shall assist the Legislativ
15	Committees in developing their charters.
16 17	BE IT FURTHER RESOLVED that any codes, by-laws or policies shall not be a
18	duplication prepared for other Indian Nations, Bands, Communities
19	or Tribes.
20	BE IT FURTHER RESOLVED that the Budget & Finance Committee shall seek
21	funding to pay costs for the services of Mr. Press.
22	BE IT FURTHER RESOLVED that the terms of the contract shall be renegotiated by
23	the Commerce Committee and final approval shall be made by the Tohono
24	O'Odham Legislative Council.
25 26	The foregoing resolution was passed by the Tohono O'odham Council on the 6th
27	day of <u>January</u> , <u>1987</u> , at a meeting at which a quorum was present with a vote of <u>900.5</u> for; <u>543.0</u> against; <u>196.5</u> not voting; and <u>02</u> absent, pursuant to the
28	powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
29	January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Acting Deputy Assistant Secretary -
20	of June 18, 1934 (48 Stat. 984).
