

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Tohono O'Odham Johnson O'Malley)



1 WHEREAS, the Tohono O'odham Nation is presently operating the Johnson O'Malley  
2 Program under FY 1987 P. L. 93-638 contract with the Bureau of Indian  
3 Affairs; and  
4 WHEREAS, such Tribal operations have been successful and beneficial to the  
5 Tohono O'odham Nation and its people; and  
6 WHEREAS, 25 CFR Section 271.20 of the Federal Regulations requires that all  
7 proposals to recontract under P. L. 93-638 be submitted to the Tohono  
8 O'odham Council for approval at least 120 days prior to the contract  
9 termination; and  
10  
11 WHEREAS, the Tohono O'odham Nation does desire to recontract for provisions of  
12 these services during FY 1988; and  
13 WHEREAS, the Tohono O'odham Council has reviewed and approved the Johnson  
14 O'Malley contract.  
15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does  
16 authorize and request the Bureau of Indian Affairs to contract with  
17 the Tohono O'odham Nation under P. L. 93-638 regulations and pro-  
18 cedures for the provision of services titled: Johnson O'Malley.

20 BE IT FURTHER RESOLVED that the approved budget is subject to change once a  
21 decision is made on the Cost of Living Allowance (COLA) rate.  
22  
23 BE IT FURTHER RESOLVED that the duration of this contract will commence on  
24 October 01, 1987 through September 30, 1988.  
25  
26 BE IT FURTHER RESOLVED that the Tohono O'odham Nation will not fund or operate  
27 a program from which contracts are requested herewith which have not  
28 been negotiated and executed by the Bureau of Indian Affairs prior to  
29 the start of the funding year.  
30  
31 BE IT FURTHER RESOLVED that Josiah Moore, Chairman; Francisco Jose, Jr., Vice  
32 Chairman or Rosita Ruiz, Treasurer, of the Tohono O'odham Nation are  
hereby authorized to negotiate and execute these contracts and any  
amendments thereto for the duration of the contracts, provided however


1 that any amendments affecting the funding or funding levels of the  
2 contract shall be submitted for further prior approval by this  
3 Council.

4 The foregoing resolution was passed by the Tohono O'odham Council on the 29th  
5 day of April, 1987, at a meeting at which a quorum was present with a vote of  
6 1497.0 for; 58.5 against; 84.5 not voting; and 03 absent, pursuant to the  
7 powers vested in the Council by Section 1 (f) of Article VI of the Constitution  
8 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January  
9 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
10 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
11 June 18, 1934 (48 Stat. 984).



25 either approve or disapprove it within 48 hours of submittal.


