

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Psychological Services)

RES. NO. 153-87

- 1 WHEREAS, the Tohono O'odham Nation is presently operating the Psychological
2 Services Program under FY 87 P.L. 93-638 contract with the Public
3 Health, Indian Health Service; and
- 4 WHEREAS, such Tribal operations have been successful and beneficial to the
5 Tohono O'odham Nation and its people; and
- 6 WHEREAS, 25 CFR Section 271.20 of the Federal Regulations requires that all
7 proposals to recontract under P.L. 93-638 be submitted to the Tohono
8 O'odham Council for approval at least 120 days prior to the contract
9 termination; and

- 11 WHEREAS, the Tohono O'odham Nation does desire to recontract for provisions
12 of these services during FY 1988; and
- 13 WHEREAS, the Tohono O'odham Council has reviewed and approved the Psychological
14 Services contract.

- 16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does
17 authorize and request the Public Health, Indian Health Service to
18 contract with the Tohono O'odham Nation under P.L. 93-638 regulations
19 and procedures for the provision of services titled: Psychological
20 Services.
- 21 BE IT FURTHER RESOLVED that the approved budget is subject to change once a
22 decision is made on the Cost of Living Allowance (COLA) rate.
- 23 BE IT FURTHER RESOLVED that the duration of this contract will commence on
24 October 01, 1987 through September 30, 1988 unless extended by mutual
25 agreement of both parties.

- 27 BE IT FURTHER RESOLVED that the Tohono O'odham Nation will not fund or operate
28 a program from which contracts are requested herewith which have not
29 been negotiated and executed by the Indian Health Service prior to
30 the start of the funding year.
- 31 BE IT FURTHER RESOLVED that Josiah Moore, Chairman; Francisco Jose, Jr., Vice-
32 Chairman or Rosita N. Ruiz, Treasurer of the Tohono O'odham Nation are


1 hereby authorized to negotiate and execute these contracts and any
2 amendements thereto for the duration of the contracts, provided how-
3 ever that any amendements affecting the funding or funding levels of
4 the contract shall be submitted for further prior approval by this
5 Council.

6 The foregoing resolution was passed by the Tohono O'odham Council on the 29th
7 day of April, 1987, at a meeting at which a quorum was present with a vote of
8 1290.5 for; 85.0 against; 264.5 not voting; and 03 absent, pursuant to the
9 powers vested in the Council by Section 1 (f) of Article VI of the Constitution
10 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
11 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
12 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
13 June 18, 1934 (48 Stat. 984).


