

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Establishment of a Tribal Action Plan in accordance with Title IV,
Subtitle C. Section 4206 (a) of the Indian Alcohol and Substance
Abuse Prevention and Treatment Act of 1986)

RES. NO. 15-87

1 WHEREAS, the Tohono O'Odham Legislative Council recognizes that alcohol and
2 substance abuse is a severe health and social problem facing the
3 Tohono O'Odham; and
4

5 WHEREAS, the Tohono O'Odham Legislative Council is desirous to protect and
6 ensure the well-being of the Tohono O'Odham; and

7 WHEREAS, the United States Congress on October 17, 1986 enacted "The Omnibus
8 Drug Enforcement, Education and Control Act of 1986"; and

9 WHEREAS, the said Act was signed into law on October the 27, 1986; and


10 WHEREAS, Title IV, Subtitle C. cited as the "Indian Alcohol and Substance Abuse
11 Prevention and Treatment Act of 1986: deals specifically with Indian
12 Tribes; and

14 WHEREAS, it is the intent of the Tohono O'Odham Legislative Council to
15 establish a Tribal Action Plan to coordinate available resources and
16 programs to combat alcohol and substance abuse.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council to
18 declare a war on alcoholism/drug abuse through the establishment of a
19 coordinating committee to coordinate efforts among resources and
20 programs to develop a Tribal Action Plan which would address the
21 problems of alcoholism and substance abuse as they relate to the
22 Tohono O'Odham Nation.

24 The foregoing resolution was passed by the Tohono O'odham Council on the 7th
25 day of January, 1987, at a meeting at which a quorum was present with a vote of
26 1502.0 for; -0- against; 138.0 not voting; and -0- absent, pursuant to the
27 powers vested in the Council by Section 1 (a)(b)(c)(2) of Article VI of the
28 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
