14	BE IT FURTHER RESOLVED that the approved budget is subject to change once a						
15	decision is made on the Cost of Living Allowance (COLA) rate.						
16	BE IT FURTHER RESOLVED that the Credit & Finance Service will commence on						
17	October 1, 1987 and end on September 30, 1988.						
18	BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman or Treasurer of the						
19	Tohono O'Odham Nation are hereby authorized to negotiate and execute						
20	these contracts and any amendments thereto for the duration of the						
21	contracts, provided however that any amendments affecting the funding						
22	or funding levels of the grant shall be submitted for further prior						
23	approval by this Council.
