


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Credit and Finance Services)

RES. NO. 160-87

1 WHEREAS, the Tohono O'Odham Nation, Legislative Council during the "Budget
2 Formulation Process" did reprogram the Self-Determination, grant to
3 establish and operate a Credit and Finance Service; and
4 WHEREAS, a Credit & Finance Service will promote and foster economic develop-
5 ment and Entrepreneurship on the Tohono O'Odham Nation Reservation;
6 and
7 WHEREAS, such a program will be beneficial to the people and the Tohono O'Odham
8 Nation.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
11 it does authorize and approve to reprogram the Self-Determination
12 grant to establish a Credit and Finance Service for FY-88.
13 BE IT FURTHER RESOLVED that the approved budget is subject to change once a
14 decision is made on the Cost of Living Allowance (COLA) rate.
15 BE IT FURTHER RESOLVED that the Credit & Finance Service will commence on
16 October 1, 1987 and end on September 30, 1988.

18 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman or Treasurer of the
19 Tohono O'Odham Nation are hereby authorized to negotiate and execute
20 these contracts and any amendments thereto for the duration of the
21 contracts, provided however that any amendments affecting the funding
22 or funding levels of the grant shall be submitted for further prior
23 approval by this Council.

25 The foregoing resolution was passed by the Tohono O'odham Council on the 30th
26 day of April, 1987, at a meeting at which a quorum was present with a vote of
27 1461.0 for; -0- against; 179.0 not voting; and -0- absent, pursuant to the
28 powers vested in the Council by Section 1 (f) of Article VI of the Constitu-
29 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
30 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
31 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
32 of June 18, 1934 (48 Stat. 984).
