

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Restoration of Credit & Finance Funds)

RES. NO. 161-87

1 WHEREAS, the Tohono O'Odham Legislative Council has authorized the establish-
2 ment of a Credit & Finance Program; and

3 WHEREAS, such program will provide assistance in preparing financial plans and
4 budgets including management & technical assistance to loan and grant
5 recipients; and

6 WHEREAS, this program will be beneficial to Tribal and Individual Business
7 Enterprises; and

9 WHEREAS, the Bureau of Indian Affairs FY 89 planning base control table
10 reflects for FY 88 an initial planning amount of \$188.6 and an adjust-
11 ment of (188.6) which reduces the FY 1989 planning base to 0.0 for
12 credit and finance.


13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
14 it hereby directs the Bureau of Indian Affairs to restore funding to
15 the Credit & Finance line item.

16 BE IT FURTHER RESOLVED that Bill Byler, Lobbyist for the Tohono O'Odham Nation,
17 is directed to follow-up on this matter to restore funding to the
18 Credit & Finance line item.

20 BE IT FURTHER RESOLVED that Congressman Morris Udall, Senator Dennis DeConcini,
21 and Senator John McCain be notified of the Bureau of Indian Affairs
22 action and the Tohono O'Odham Nation respectfully request their
23 assistance in restoring the Credit & Finance funds.

25 The foregoing resolution was passed by the Tohono O'odham Council on the 30th
26 day of April, 1987, at a meeting at which a quorum was present with a vote of
27 1456.6 for; -0- against; 183.5 not voting; and -0- absent, pursuant to the
28 powers vested in the Council by Section 1 (j) of Article VI of the Constitu-
29 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
