

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Cost of Living Consideration)

RES. NO. 162-87

1 WHEREAS, the Legislative Council reviewed the fiscal year 1988 P. L. 93-638
2 Contracts on April 30, 1987; and


3 WHEREAS, no provisions were made in the budgets to cover any Cost of Living
4 Allowance (COLA) for Tribal employees; and

5 WHEREAS, the Legislative Council is in the process of reviewing and determining
6 a Cost of Living Allowance rate for all Tribal employees.


7 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that a Cost of Living
8 Allowance rate will be considered to cover all Tribal employees.

10 The foregoing resolution was passed by the Tohono O'odham Council on the 30th
11 day of April, 1987, at a meeting at which a quorum was present with a vote of
12 1292.0 for; -0- against; 348.0 not voting; and -0- absent, pursuant to the
13 powers vested in the Council by Section 1 d (2) of Article VI of the Constitu-
14 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
15 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
16 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
17 of June 18, 1934 (48 Stat. 984).


