1 WHEREAS, the Gu Achi District Council has considered and reviewed its amended  
2 activities for FY '87 and had prepared a proposed budget amendment to  
3 cover anticipated cost and expenses; and

4 WHEREAS, the Gu Achi District Council did adopt and approve the proposed  
5 budget amendment for FY 87 in the amount of \$159,235.47; and


6 WHEREAS, the Tohono O'Odham Council has reviewed the proposed budget amendment

10 day of April, 1987, at a meeting at which a quorum was present with a vote of  
11 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the powers  
12 vested in the Council by Section 1 (d) of Article VI of the Constitution of the  
13 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).


24 Said Resolution was submitted for approval to the office of the Chairman of the


