
1 WHEREAS, the Tohono O'Odham Legislative Council did by Legislative Order

7 Harriet Toro as Chairperson of the Tohono O'Odham Legislative Council.


8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that

15 powers vested in the Council by Section 1 (b) of Article VI of the Constitu-
16 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).






