
1 WHEREAS, the Tohono O'Odham Legislative Council did by Legislative Order
2 (Resolution No. 180-B-87) cast a majority of its votes in favor of
3 Andrew Patricio, as Vice-Chairman of the Tohono O'odham Legislative

6 WHEREAS, this Council hereby wishes to commemorate and certify its election of
7 Andrew Patricio as Vice-Chairman of the Tohono O'Odham Legislative
8 Council.


9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
10 it hereby commemorates and certifies the election of Andrew Patricio
11 as Vice-Chairman of the Tohono O'Odham Legislative Council.

13 The foregoing resolution was passed by the Tohono O'odham Council on the 1st.
14 day of June, 1987, at a meeting at which a quorum was present with a vote of
15 1404.0 for; 183.5 against; 52.5 not voting; and -0- absent, pursuant to the
16 powers vested in the Council by Section 1 (b) of Article VI of the Constitu-
17 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
18 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
20 of June 18, 1934 (48 Stat. 984).






