RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Retention of current number of votes allowed for each District and referring matter to the Rules Committee)

WHEREAS, Mr. Sylvester Listo a member of Sells District and other members of the Sells District Council did submit a notice formally contesting the number of votes allocated to Sells District; and

WHEREAS, the Tohono O'Odham Legislative Council discussed the matter of re-examining the process of allocating votes to each district based on the number of residents and traditional members of each district; and WHEREAS, the Sells District Council requests that such allocation be used on the number of people residing in Sells.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does not certify the number of votes presented by the Election Board and to stay with the existing number of votes and to refer to the Rules Committee to provide recommendations or options to establish a voting system more accurate and fair, in making the recommendations, to take into consideration provisions of the Constitution and concept of full representation of all members.

BE IT FURTHER RESOLVED that a ninety (90) day time frame be allowed from the time of enactment to report recommendations or options.

The foregoing resolution was passed by the Tohono O'odham Council on the 1st day of June, 1987, at a meeting at which a quorum was present with a vote of $\underline{1143.5}$ for; $\underline{299.5}$ against; $\underline{197.0}$ not voting; and $\underline{-0-}$ absent, pursuant to the powers vested in the Council by Section 1 (b) & (g) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
