


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Retention of current number of votes allowed for each District and
referring matter to the Rules Committee)


1 WHEREAS, Mr. Sylvester Listo a member of Sells District and other members of
2 the Sells District Council did submit a notice formally contesting the
3 number of votes allocated to Sells District; and
4
5 WHEREAS, the Tohono O'Odham Legislative Council discussed the matter of
6 re-examining the process of allocating votes to each district based on
7 the number of residents and traditional members of each district; and
8
9 WHEREAS, the Sells District Council requests that such allocation be used on
10 the number of people residing in Sells.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does
13 not certify the number of votes presented by the Election Board and to
14 stay with the existing number of votes and to refer to the Rules
15 Committee to provide recommendations or options to establish a voting
16 system more accurate and fair, in making the recommendations, to take
17 into consideration provisions of the Constitution and concept of full
18 representation of all members.

20 BE IT FURTHER RESOLVED that a ninety (90) day time frame be allowed from the
21 time of enactment to report recommendations or options.

23 The foregoing resolution was passed by the Tohono O'odham Council on the 1st
24 day of June, 1987, at a meeting at which a quorum was present with a vote of
25 1143.5 for; 299.5 against; 197.0 not voting; and -0- absent, pursuant to the
powers vested in the Council by Section 1 (b) & (g) of Article VI of the Con-
stitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
