

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Teresa Choyguha as Secretary for the
Tohono O'Odham Legislative Council)

RES. NO. 184-87

1 WHEREAS, Section 5 of Article VI of the Constitution of the Tohono O'Odham
2 Nation requires the Tohono O'Odham Legislative Council to select a
3 Secretary from without its membership.

4 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council
5 hereby appoints Teresa Choyguha as Secretary of the Tohono O'Odham
6 Legislative Council to serve until replaced by the Legislative
7 Council.

10 The foregoing resolution was passed by the Tohono O'odham Council on the 2nd
11 day of June, 1987, at a meeting at which a quorum was present with a vote of
12 1327.0 for; 244.0 against; 69.0 not voting; and -0- absent, pursuant to the
13 powers vested in the Council by Section 1 (b) of Article VI of the Constitu-
14 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
15 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
16 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
17 of June 18, 1934 (48 Stat. 984).


