
1 WHEREAS, the following named persons have formally relinquished their


9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does

17 1 (h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
18 O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant  
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
20 16 of the Act of June 18, 1934 (48 Stat. 984).



either approve or disapprove it within 48 hours of submittal.


