LEGISLATIVE ORDER NO. 197-87

1 WHEREAS, the Tohono O'Odham Legislative Council is appointing members to all  
2 legislative committees based on the procedures outlined in the Legis-  
3 lative Rules; and

4 WHEREAS, the Rules addresses the retention request of current members, followed  
5 by seniority preference requests and finally considers Declaration of  
6 Candidacy; and

7 WHEREAS, new members of the Legislative Council would like to give all  
8 certified members of the legislature an opportunity to file their  
9 candidacy for the remaining committees by seeking a waiver of the  
10 retention and seniority preference; and

11 WHEREAS, Rosita Ruiz of Chukut Kuk District and Joann Garcia of Baboquivari  
12 District formally announces their candidacy to the remaining com-  
13 mittees.

16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does  
17 hereby waive ARTICLE XII, SECTION 3.B., RETENTION OF CURRENT COMMITTEE  
18 MEMBERSHIP and C. SENIORITY PREFERENCE APPOINTMENT of the Legislative  
19 Rules.

29 above.


30 The foregoing Legislative Order was passed by the Tohono O'odham Council on the

January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
of June 18, 1934 (48 Stat. 984).
