NOW, THEREFORE, BE IT RESOLVED that the matter of disposition of Accounting records be referred to the Rules Committee who will take the lead in conjunction with the Budget & Finance Committee for recommendations to the Legislature.

The foregoing resolution was passed by the Tohono O'odham Council on the $\underline{3rd}$ day of \underline{June} , $\underline{1987}$, at a meeting at which a quorum was present with a vote of $\underline{1198.5}$ for; $\underline{372.5}$ against; $\underline{69.0}$ not voting; and $\underline{01}$ absent, pursuant to the powers vested in the Council by Section $\underline{1}$ (b) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
