
1 WHEREAS, the Sells District Council by Resolution No. 6286 have consented to

6 Section 1.


7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council

14 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).



29 either approve or disapprove it within 48 hours of submittal.


