

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(San Xavier Cooperative Farm Rehabilitation Plan)

RES. NO. 218-87

1 WHEREAS, Section 303 (a), (1), (B) of the Southern Arizona Water Rights Settle-
2 ment Act of 1982 (The Act) requires the Secretary acting through the
3 Bureau of Reclamation to improve and extend the existing irrigation
4 system on the San Xavier Reservation and design and construct such
5 additional canals, laterals farm ditches and irrigation works as are
6 necessary for the efficient distribution for agricultural purposes of
7 the water; and

8 WHEREAS, the San Xavier Cooperative Association, Inc. has reviewed various land
9 use and alternative water delivery points prepared by Franzoy-Corey
10 Engineers and Architects; and


11 WHEREAS, the San Xavier Cooperative Association, Inc. approved the attached San
12 Xavier Farm Rehabilitation Project Alternative 3A; and

13 WHEREAS, the San Xavier District Council concurs with the approval of the San
14 Xavier Cooperative Association, Inc.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
16 it does hereby approve the San Xavier Farm Rehabilitation Development
17 Plan as selected by the San Xavier Cooperative Association, Inc., as
18 the most suitable to improve and extend the existing farm on the San
19 Xavier Reservation.

22 The foregoing resolution was passed by the Tohono O'odham Council on the 5th
23 day of June, 1987, at a meeting at which a quorum was present with a vote of
24 1358.5 for; 217.5 against; 64.0 not voting; and 03 absent, pursuant to the
25 powers vested in the Council by Section 1 (j) of Article VI of the Constitu-
26 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
27 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
